### **Priority Goals and Targets FY2024**

#### **CLIMATE PLEDGE**

Main Line Health joined nearly 140 organizations in signing on to the White House/Health Sector Pledge, aiming to cut greenhouse gas emissions by 50% by 2030 and achieve net zero emissions by 2050.

- Overview and Requirements: Must annually account for progress publicly on emissions reduction, assign executive-level lead, take inventory of all Scope 3 emissions, develop climate resilience plan for continuous operation
- Climate Resiliency Plan: Work in collaboration with sustainability experts underway:
  - Identify and quantify climate vulnerability and risk (physical and transitional) due to climate change
  - Take social equity into account by anticipating and analyzing any climate-related impacts that continued operations have on the environment and the needs of groups in the community that may be disproportionately impacted by the environment

#### **PRACTICE GREENHEALTH**

- Nominated Lankenau Medical Center for Practice Greenhealth's Partner for Change award, given to healthcare facilities showing continuous improvement in areas such as waste reduction, renewable energy adoption, food purchasing and mercury elimination
- Although Lankenau did not receive the award, the effort provided valuable data to help benchmark the state of the healthcare industry
- Practice Greenhealth will provide a Benchmark Report Card on the hospital's performance, helping compare sustainability efforts to those of its peers now and into the future. Working with Practice Greenhealth's industry thought leaders provides information, tools, data, resources and expert technical support to its hospital partners

#### SUSTAINABLE OPERATIONS GUIDELINES

- Overview: New initiative to standardize sustainability operations across Lankenau Medical Center, Bryn Mawr Hospital, Paoli Hospital, Riddle Hospital and Bryn Mawr Rehab Hospital
- Vision: Annual standardized process with three primary goals:
  - Increase operational efficiency
  - Identify and prioritize necessary capital expenditure investment
  - Enable tracking of progress against FY24 baseline at each hospital
- Areas of focus: energy usage, waste, food, landscaping, community gardens, water usage

 In progress: Collecting baseline data, prioritizing operational efficiency improvements, identifying capital expenditure opportunities to incorporate in next year's budget







# ENERGY EFFICIENCY AND CARBON REDUCTION PROJECTS

Main Line Health remains dedicated to our sustainability objectives, continually seeking opportunities to improve energy efficiency. We have implemented various initiatives to achieve our goals.

- LED lighting upgrades: Provide energy savings and enhanced lighting quality throughout our facilities
- HVAC setback controls: Ensure that energy usage aligns with specific needs in different areas, reducing energy consumption and improving overall operational efficiency
- Chiller optimization program: Through close monitoring, analysis and fine-tuning of chiller operations, seek to achieve optimal efficiency and reduce energy consumption

#### **WATER EFFICIENCY PROJECTS**

Main Line Health has implemented various measures to conserve water across our hospital.

- Identification and resolution of water leaks and inefficiencies: Through proactive measures, promptly addressed and fixed leaks to minimize water waste and ensure efficient operations
- Reduction of makeup water usage: Enhanced water conservation
- Upgrade water fountains to more efficient models: Reduced water consumption while providing convenient access to clean drinking water for patients, visitors and staff
